Enrollment Contract Terms for the 2019-2020 School Year (September 4, 2019 – June 10, 2020).

Registration Deposits, Payment Terms, Discounts

- The registration fee (\$190 returning/siblings or \$250 new students) and tuition deposit (10% of annual tuition as enrolled) are **nonrefundable** and **nontransferable** once this enrollment contract is submitted.
- The **nonrefundable** tuition deposit of 10% of the annual tuition and the nonrefundable registration fee is due upon registration along with this enrollment contract. Tuition security deposits may only be applied to the last installment of the school year and cannot be used for September through May tuition installments, summer school or other charges.
- Tuition is a school year program fee, due in its entirety regardless of absence due to illness, vacation or any other circumstance. It may be paid as a lump sum or divided into ten equal installments (it does not fluctuate based on the number of school days in any given month). School year tuition paid in full by September 10th will be discounted by 3% only if paid by check or in cash.
- Tuition is computed according to the number of actual school days in a school year and does not include holidays, vacations, in-service, and conference days. Any daycare used on these non-school days will be billed separately.
- Tuition is due on the first day of each month. You will not receive a physical bill for tuition unless payment is past due.
- Payments can be made in cash, by check, by Visa, MasterCard or American Express.
- There are no refunds or credits for absences, vacations, emergency closures or snow days.
- A \$10 late fee will be applied for payments received after the 7th of the month.
- If an account is more than one month in arrears, payment arrangements must be in place to maintain enrollment.
- Credit card information is required upon registration to be used by SMS in the event of a 30-day past due balance.
- Checks returned by a bank will be subject to a \$35 charge.
- A 5% discount is applied to each child's tuition for families with more than one child attending SMS concurrently.
- Discounted unlimited prepaid Early Birds and After School Club daycare must be paid by the 1st of the month or any daycare used will be billed at the hourly rate.
- A surcharge of \$2 per minute will be assessed for daycare pick-up after 6:15PM. This is in addition to the hourly rate.
- In the event that more than one individual assumes financial responsibility for tuition and other charges, all such parties must sign this enrollment contract. If only one signature is provided, that individual assumes full financial responsibility for all charges. No state funding (direct or indirect) is accepted as payment.

Emergency If my emergency contacts and I cannot be reached in an emergency, I authorize the director, business manager, or my child's teacher to care for my child until I can be reached, including transporting my child as needed.

Field Trips I authorize my child to participate in school field trips. I understand that I will be given prior notice of each trip.

Photo Authorization I allow my child to be photographed or filmed in the classroom, on school field trips or during other school functions. I give permission for any such images to be used in SMS newsletters, website or Facebook, presentations, for SMS marketing or in other SMS properties and to be made available to parents of other SMS students. (If you wish to opt out of public posting for marketing, on Facebook or the Internet please provide a written request asking for your child to be excluded, specifying what you wish to exclude and what you are comfortable with.)

Speed Limit and Traffic Rules I agree to drive slowly (10 mph max) and obey all traffic rules on/around SMS property.

Withdrawal From School During the School Year

I understand that: 1) enrollment is a commitment for the entire school year and I intend to complete the entire school year without interruption; 2) registration fees and tuition deposits are a nonrefundable and nontransferable security deposit to reserve my child's space for the school year and I forfeit the security deposit if I withdraw my child or reduce my child's schedule; 3) if unforeseen circumstances occur that make it impossible for my child to attend the full school year, I agree to provide written notice by the first of the month the month ahead of the withdrawal date and if I do not provide such written notice, I agree to pay one tuition installment instead (in addition to the initial security deposit paid to secure space for the school year); 4) if I do not provide a written notice of withdrawal, I am responsible for paying for the entire school year regardless of attendance.

Withdrawal Prior to the School Year

I understand that 1) the school must be informed, in writing, no later than August 1, 2019 if my child will not be attending and if I fail to do so I am responsible for the September tuition payment; 2) if I fail to provide written notice of withdrawal, I am responsible for paying for the entire school year regardless of attendance; 3) the registration fee and tuition deposit are nonrefundable security deposits to reserve my child's space for the school year and if I choose to withdraw my child or reduce my child's schedule once I have enrolled him/her, I forfeit the associated security deposit.
